

RULES FOR INTERNET AND INTRANET ACCESS

1. Purpose

1.1. These rules apply to all kinds of Internet and intranet activity on the data communication network of the hall of residence and lay down the more specific instructions for use of the data communication network.

2. The data communication network

2.1. The data communication network is part and parcel of the hall of residence package deal with the individual resident, and it can thus not be rejected from the firm offer.

2.2. The data communication network consists of the physical cabling from each hall of residence to a joint cross field in server rooms and any hardware in the shape of e.g. server, network switches etc., which are placed at the disposal of the residents by the hall of residence. The hall of residence does not place software at the disposal of the residents. All setting up and running etc. of the internal data communication network is managed by the hall of residence, and particularly the board of the hall of residence and/or the network committee.

2.3. In the data communication network the following basic services are placed at the disposal of the residents:

- Access to Internet provider via the co-operation of the hall of residence with the main network (Bolignet-Aarhus).
- Possibility of internal data communication via the data communication network.

2.4. The hall of residence can, but has no obligation to offer additional services to the residents.

3. Price and payment

3.1. The residents pay a monthly charge, set according to the budget of the hall of residence, for the services that the hall of residence offers on the data communication network. The monthly charge is set according to the expenses to the main network and the running of the internal network.

3.2. The fee is charged monthly with the rent.

4. Instructions for the residents' use of the data communication network

4.1. By any kind of use of the data communication network, the residents must follow the instructions below:

4.2. The residents must with regard to all activity on the data communication network respect the legislation in force at the time in question, including the copyright legislation, all other intellectual legislation and law.

4.3. E-mails are confidential. Any attempt of tapping or intercepting the e-mails of the data communication network or of other residents or other network traffic is not allowed and will be a violation of the law's rules on secrecy of mail.

4.4. The residents must not store, distribute or in any other way make illegal material available on the data communication network, neither via own computer, on server place/web hotel nor any other way.

4.5. Any attempt to effect an entrance to or to get information about the computers of other residents or of a third party, for instance by port scanning or the like, is not allowed, unless the person in question has given his or her accept.

4.6. It is not allowed entirely or partly to resell or in other ways pass on Internet access or other network services on the data communication network.

4.7. The residents must furthermore respect the rights of other actors within as well as without the data communication network framework, and residents must besides that by any use of the facilities of the data communication network observe normal practice for Internet use, i.e. netiquette, and furthermore show fair consideration when using the facilities of the data communication network.

4.8. The hall of residence, the board of the hall of residence or the network committee reserves the right to report violations to the police.

4.9. The residents are committed to follow the recommendations or orders of the hall of residence/board of the hall of residence given because of the residents' use of the data communication network.

5. Breach of the residents

5.1. If a resident does not keep his or her obligation to pay, the administrator of the hall of residence is authorised to deprive the resident concerned of access to the net by disabling. Disabling takes place with prior notice to the resident in question in connection with the letter requesting payment.

5.2. If the residents do not keep the instructions described in 4, the access to the net will be interrupted by disabling. The decision to shut down net access can be taken by the board of the hall of residence or the network committee in consultation with the board of the hall of residence.

5.3. If violation of these rules is suspected or pointed out and in particular the laid down instructions in 4., the network committee is under the obligation to inform the board of the hall of residence as soon as this is demonstrated.

5.4. Violation of the rules in 3. and 4. can lead to deprivation of access to the data communication network. The access of the residents to the data communication network can moreover be deprived if orders are given by police, courts, other public legal capacities or external third parties.

6. Responsibility

6.1. The hall of residence can in no way guarantee uptime, functionality and quality of the data communication network's offers to the residents.

6.2. The hall of residence has no responsibility for defects and cannot be held liable in damages regarding the residents for loss in connection with the residents' use of the data communication network, including with regards to running and uptime of servers, transmission of data and uptime on the Internet access and no responsibility if the external Internet provider shuts off.

6.3. The residents have no remedies for breach towards the hall of residence, its board and others connected here to.

6.4. The hall of residence and the board of the hall of residence have no connection to the daily running and have no responsibility for the content of and the activity on the data communication network and the connected resources, neither towards the residents, nor towards third parties.

6.5. The board of the hall of residence and the network committee have no responsibility for the content of possible resources given to the individual residents, or resources put up by the individual residents.

7. Network committee

7.1. The board of the hall of residence can choose a network committee to be in charge of the daily running of the data communication network. The number of members and the election period are decided by the board of the hall of residence.

7.2. The network committee is committed to comply with these rules and follow directions and instructions from the board of the hall of residence.

7.3. The network committee and other technical and administrative staff have a complete duty of confidentiality in connection with the carrying out of their job.

7.4. In connection with the administration and the running of the communication data network, the network committee, in so far as it is necessary, will carry out the usual registration and treatment of information. In this process private information can occur. The registration and treatment of information are only done inside the usual running and administration of the data communication network, including among other things administration of users, handling of security etc.

7.5. For important reasons as regards security, for instance reasoned suspicion about hacking, harassment, virus-danger or similar, the network committee can, in connection with the running, make investigations, including the opening of e-mails and supervision and treatment of activity on the data communication network. The network committee informs in pursuance of 5.3.

8. House rules

8.1. These rules are part of the house rules of the hall of residence.
